Dear Governor Cuomo, Temporary President Flanagan, and Speaker Heastie:

The National Hispanic Leadership Agenda (NHLAA) strongly supports increasing the minimum wage to \$15 per hour. Recently, the NHLA adopted its Public Policy Agenda in which its calls for raising the minimum federal minimum wage to \$15.00 per hour by 2020, which would benefit at least seven million Latino workers, and our coalition supports raising state minimum wages to that level as a step toward that goal.

The NHLA is a premier coalition of the nation's 40 prominent Latino organizations. Collectively, the NHLA leads the advocacy behind the pressing civil rights and policy issues impacting the 58 million Latinos living in the United States. The NHLA strives to increase Latino visibility and leverages its efforts to build a stronger Latino influence in our country's affairs.

As the largest and fastest-growing minority group, Latinos comprise an increasingly important segment of the U.S. workforce. However, Latinos are overrepresented in low-wage occupations and have lower levels of household wealth than other racial and ethnic groups. Because Latinos are overrepresented in low-wage jobs, the effect of wage stagnation on their sense of economic well-being is particularly profound, with 67% of Latinos reporting in a recent poll that they are not earning enough to meet their basic expenses. Losses of household wealth and poverty wages have contributed to the situation today where about one in four Latinos live in poverty. In fact, 42% of all Latinos earn poverty-level wages despite having the highest rate of labor force participation among all racial and ethnic groups. Low wages have real consequences, especially for women, immigrant families, and people of color, who are disproportionately affected by low pay.

Hard-working families should be able to earn a living that supports their needs. Raising the minimum wage is among the policy changes needed to achieve this objective. The federal minimum wage and most state minimum wage requirements have fallen drastically in real economic terms and should be increased substantially. Several states have recognized the need to raise the minimum wage substantially and we encourage New York State to join this group.

The NHLA is concerned about reports of a potential discriminatory exclusion of agricultural workers from the full benefits of an increase in the minimum wage. Our coalition has a special

interest in ensuring that agricultural workers' wages and working conditions – which are among the poorest in the state - improve and are not subjected to discriminatory policies. The large majority of farmworkers is Latino.

Like all other workers, the hardworking farm laborers in New York who pick apples, milk cows and grow and harvest the state's vegetables deserve a fair wage for their work. They are the backbone of the state's agricultural economy and perform difficult, back-breaking work. Farmworkers should be treated with dignity, respect, and equality under the law. The people who labor on farms, as a group, experience very low wages and rarely receive fringe benefits. The minimum wage is an important protection to reduce poverty among farmworker families. In fact, many agricultural employers recognize the need to improve wages and benefits to attract and retain productive workers on their farms. In addition, consumers, who often prefer to purchase locally-grown and —raised food, also want to know that it has been grown and raised responsibly. There are other policy proposals that should be adopted to grant farmworkers labor protections similar to those applicable to other New York businesses. At this moment, raising the minimum wage for the state's farmworkers should be a priority.

Please support a \$15 per hour minimum wage for ALL New York workers.
